

2. The minimum detectable limits for analysis of heavy metal in water sample should not be more than 0.001 ppm for Mercury, 0.005 ppm for Copper and 0.02 ppm for Chromium. Please state the method by which the samples are going to be tested.
3. Copy of Laboratory License / Laboratory Registration Certificate as well as copy of the Certificate stating as NABL (National Accreditation Board for testing and Calibration Laboratories, Department of Science & Technology, Government of India) accreditation of the same laboratory as applicable along with the quotation.
4. The Basic price, applicable taxes (i.e. GST or any other taxes) and other charges such as Packing, Forwarding, Transportation etc. be mentioned in detail.
5. Terms and conditions regarding payment, delivery and guarantee should be mentioned clearly. However, the results should be sent to F.O.R. Shirgaon, Ratnagiri. The payment will be made against the delivery of the results. Please note that any Bank formalities will not be accepted by this office.
