### Appendix – I (Part I)

#### Terms and conditions of Tender for Sale of unserviceable articles (Second Demand)

1. Sealed Tenders are invited from individuals/authorized auctioneers of unserviceable article as per given in Appendix-II during 10:30 am to 15:00 pm on working days w.e.f **22<sup>nd</sup> January, 2021 to 5<sup>th</sup> February, 2021**. Tenders received late will not be considered. In case tenders are sent by Registered post, it shall be the responsibility of intending suppliers to ensure that they are received before closing hours. The tenders are proposed to be opened on **5<sup>th</sup> February, 2021** at 16:00hours in the presence of the intending suppliers or their authorized representatives who may desire to attend.
2. The cost of purchasing both in words and figures without any corrections or overwriting should be quoted in Appendix - II for each individual item separately. Any overwriting or rewriting should be duly countersigned. The cost of purchasing must be valid for a period of at least one months from the date of closing of execution of Agreement. The rates must be quoted in Indian National Rupees (Rs). Rates quoted in foreign currency will not be accepted.
3. University will accept the tender for items mentioned in Appendix – II. University reserves the rights to accept or reject tenders of these agencies. The decision of the University regarding this will be final and shall be binding on the tenderer.
4. Tenderer will have to uplift the material as it is and where it is from the MBRS within 15 days from execution of Agreement.
5. The University reserves the right to accept or reject the items of the make other than the above.
6. The tenderer should quote the rates only in Appendix II of the tender floated on website by this office and not on any other form.
7. The tenderer should submit his offer in **two separate envelopes** supplier should submit attested true copy of required paper in envelope No.1, if he do so fail envelope No. 2 will be not opened
8. The tenderer should provide the following documents in *first envelope (A)* with superscription "**Tender for purchase of unserviceable articles**":
  - a) D. D. for E.M.D. and cost of tender form (Rs. 500/-) (if tender form is obtained through Website.), separately. b) Clients list of Company and total experience in this field. (If any) c) Part - II of Appendix – I.
9. The tenderer should provide rates quoted only in Appendix II in *second envelope (B)* with superscription "**Tender for sale of unserviceable articles**".
10. The intending supplier should quote the rates inclusive of all expenses, charges, taxes, duties, transportation, packing and forwarding, insurance, installation etc. i.e. All "Inclusive". The material will have to be uplift within 15 DAYS or as per the last date mentioned in final order.
11. University will reserve full rights to open/consider the second envelop (B) if and only if University is satisfied with the information contained in the first envelope (A). The decision of the University regarding this will be final and shall be binding on tenderer.
12. The purchase will have to supply in full and not in part of the articles as mentioned in Appendix - I to this office.
13. If the material is not lifted within stipulated time limits, penalty @ 1% of the total cost order value per week for extra time taken will be charged. However, the undersigned may condone/relax the penalty and may grant extension up to the time limit as deem fit by him, provided the Tenderer applies and satisfies about genuineness of the reasons for delay in lifting the articles.
- 14 The Tenderer shall have to deposit Earnest Money Deposit (E.M.D.) as specified (5 % of the cost of tender) by Demand Draft drawn in favour of **Dr. B. S. Konkan Krishi Vidyapeeth payable at Ratnagiri** and the same should be enclosed along with the tender. The tender without E.M.D. will not be considered at all & as well as this will be rejected. The amount of E.M.D. will be refunded in case of unsuccessful tenderer on submission of plain application with Money Receipt in original and an advance stamped receipt soon after the final decision. However, in respect of State Agricultural Universities, Central Government undertakings, State Govt. undertakings, Central Govt. Institutes and Institutes affiliated by Indian Council of Agricultural Research the condition of depositing Earnest Money Deposit is not applicable. However, final decision in the matter is rested with the University.
15. The Specimen of "Agreement Bond" will be provided along with letter of acceptance to the Tenderer whose rates are accepted by the undersigned. The Tenderer shall have to execute an agreement in the prescribed form on Stamp paper costing Rs. 100/-, which should be submitted to this Office within specified time& progress of work should be observed. The agreement received under seal and

signature of the Tenderer will become legal agreement between the Tenderer and the undersigned, which will be binding on the Tenderer.

16. If the successful Tenderer fails to lift material within the specified period or only part purchase is made, the undersigned or respective authority or any officer authorized by him/them, will arrange for the alternative arrangement through any other or agency at risk, cost and expenses of the said Tenderer, who shall have to bear and pay all additional expenditure incurred by the University in that behalf.
17. Successful Tenderer will have to furnish token deposit to the extent of 1% of total cost of the items accepted by the University as offered in the tender through demand draft drawn on any nationalised bank in favour of Dr. B.S. Konkan Krishi Vidyapeeth, payable at Ratnagiri within two days.
18. On acceptance of the rates as per the approved tender and after completing necessary official formalities, the Tenderer will be informed about the acceptance of the tender. The order will be placed by the undersigned.
19. As soon as the Tenderer delivers the tender in the office of the undersigned, it shall be binding on him and he shall not be able to withdraw or amend the offer.
20. The undersigned reserves the right to obtain the articles by negotiations from one or more of the Tenderer, if in case the cost of tenderer are not found suitable, to this office.
21. The undersigned also reserves the right to accept or reject the cost quoted by Tenderer.
22. The successful tenderer shall further pay remaining cost of the items accepted by the University as offered in the tender through demand draft drawn on any nationalised bank in favour of Dr. B.S. Konkan Krishi Vidyapeeth, payable at Ratnagiri within specified time from the date of issue of letter of acceptance.

For any delay in payment, interest or any other kind of compensation/the University will has right to charge extra charges/ interest etc. This contract will be governed as per terms and conditions mentioned above, Agreement made and the provisions contained in M.A.U account Code, 1991.Delay in credit amount within the prescribed time limit or the extended time limit, not up to non-acceptance of these terms and conditions by the tenderer, shall constitute breach of contract and the security deposit or any other deposit of the tenderer shall be forfeited by the University besides other actions of the penalties and / or other legal actions and finally the decision of the University shall be binding on the tenderer.
