- :- 1. Candidates working in various schemes/projects should submit the NOC from the concern Incharge along with application form.
 - 2. The position is purely temporary and will be filled on contractual basis till the termination of the scheme or as per the need, whichever is earlier. Duration of engagement can be curtailed/extended as per need and subject to performance of the candidate.
